Additional Notice Round III:- B.Ed. (General and Special)

CET Cell had taken out a Notice for Round III as cited under reference. Some college had some doubts regarding filling of the seats and conversion of the seats hence this additional notice.

There is no Management Quota in any College of Education as per Directives of NCTE and Department of Higher Education. All seats are ACAP seats,

A) Admissions to English Medium Colleges only through ELCT Qualified Candidates: -

- I. Colleges must fill the seats in English Medium colleges only through the ELCT Qualified candidates who have applied for Round III Admission in the College.
- II. In No case Merit is to be violated.

B) Logic for Change of Category:

Has been explained in detail in Notice No 3 cited under reference, yet further clarification is being given.,

- 1. The category seat is to be filled from the particular category candidate
- 2. All category seats are to be filled in by inter se merit of all category candidates if the candidate of particular category in not available but minding the subject/ method of the vacancy.
- 3. If still seat remain vacant All category including Open candidate' Inter Se Merit list is to be prepared and admissions are to be done.

C) Logic for Change of Gender Seats (Female Seats Transfer)

1. If the seats of particular subject remain vacant, those will be filled in by making changes as shown below by the Centralized Admission Committee. (Only for B.Ed.)

2. If seats remain vacant from the reservation of women in particular subjects / category, then vacant seats will be merged in General Merit List of the same category and subject seats will be filled in.

D) Logic for Change of subject/ Method seat:-

- 1. Interchange within Language Group.
- 2. Interchange within Science and Agriculture/ Medical.
- 3. Interchange between Information Technology, Engineering and Mathematics
- 4. Internal change between Science and Mathematics.
- a. If the seats remain vacant after executing above interchanges of Languages, Science, Mathematics and Commerce, then those seats will be distributed to History Geography, Social Science as per the quota allotted to these subjects.
- b. Inter changes between History and Geography after interchanging, if some Seats remain vacant, they will be allotted to Social Science
- c. If some seats still remain vacant, a consolidated merit list of all the subjects will be prepared and then seats will be filled on the basis of combined merit of all subjects.
- d. The colleges should consider the Graduation Special/ optional subject for determining the method even though the candidate has validated his form on PG qualification.
- e. Some Non subjects have quota specified in the Admission rules, colleges have refused the admissions to this quota candidates stating that the college does not have this method. This is not legal. The college can accommodate these candidates in the method as per the SSC/HSC background of the candidate is the rules of University permit.

E) Logic for Change of Quota seat:-

If the seats remain vacant after executing above interchanges of Methods, then those seats will be distributed to other quota Candidates as per the following priority Steps

- a. HU Quota interchange with OHU Quota (Inter MS group Transfer)
- b. If seat remains vacant transfer to OMS
- c. NRI quota (If Vacant) interchange with MS candidates. In vacancy NRI quota already transfer to HU & OHU quota.
- d. If some seats still remain vacant, a consolidated merit list of all candidates will be prepared and seats will be filled on the basis of *inter-se-Merit*.

The colleges and Institutes will follow the provisions in the Information Brochure and the Government Notification cited under reference for filling in the vacant seats after CAP Round 3 Institutional level round.

- The Colleges will generate the Candidature Type wise Merit list using the facility on admission. The same merit list should be displayed on the College Notice Board and College Web Site.
- The Colleges will download the Provisional Admission Letter by filling the relevant admission details of the seat and the candidate and verify the

credentials of the candidate and confirm the admission from the college log in before the due date.

- The Third Institute Level round is being conducted at the level of the College and as per the Provisions in the Government Notification cited under reference. It will be responsibility of the Heads of the Institute to fill in the vacant seats as per the Schedule given and provisions contained in the Information Brochure and Government Notifications.
- The link for paying the seat acceptance fee is in the college log in. No college should ask candidate to pay seat acceptance fee without due verification of documents.
- Colleges who have been given additional division as per Hon. High court order will invariably upload the joint undertaking of the College Principal and the Candidate.

Regarding refusal of Admission by the college:-

- 1. The colleges cannot officially refuse the admission without any valid reason on the verification form of admission.
- 2. Kindly complain to Director Higher Education, Central Building, Pune 411001 in writing with all your details CAP application form, Allotment letter, when did you go there, to whom did you meet, what did they say.
- 3. We are going to forward all complaints to the National Council of Teacher Education, New Delhi through Department
- 4. kindly send the copy of the same to CET CELL.

Regarding overcharging of Fees by the Colleges of Education:-

- We have directed the candidates to complain in writing to Joint Director, Shikshan Shulka Samiti B.Ed.-M.Ed. 3, Mahapalika Marg, Dhobi Talao. Mumbai 400001 regarding this.
- 2. We had asked the college to upload the fee on our College registration portal https://bed.hepravesh.in/.
- 3. We have also directed the colleges to upload the same on their web site
- 4. You have to apply with full credentials and proofs to the Quasi-Judicial Authority with your signature and documents enclosed duly certified by the Candidate.

Regarding CVC/NCL/EWS Certificate and Admission:-

- 1. CET CELL had published two Notices No. 2098 dated 23/12/2021 and No. 2263 dated 27/12/2021.
- 2. College should have read the above two Notices published on the CAP Course web page and follow the schedule given in the notices regarding cancelling the admission of the candidate who has uploaded the CVC/NCL/EWS Application Submission Receipt on the admission portal but has not physically submitted the TVC/CVC/NCL/EWS on the day specified in the notices. The Colleges/Institutes/ Departments are duty bound

to give intimation to such candidates in writing beforehand and then cancel the admission on the day specified in the notices.

- 3. No college should have the candidate admitted on the college role the candidate who does not have CVC/EWS/NCL certificate as applicable. Any case arising out of this will be full responsibility of the College only.
- 4. All colleges will have pre-declared Admission Committee and the committee will have daily proceeding with signature of all the members and countersigned by the Principal of the College.
