After cut-off date of the admission which declared by CET CELL in the schedule and submitted in the Hon. Court in various cases, a verdict in WP 3069/2022 in the Hon. The candidates will be editing the form and uploading the documents at their own risk. **There will be no scrutiny of the documents and application edited by the candidates.**

Since the seats are very less and the Candidates are Many times more than the seats available in the State of Maharashtra, the unadmitted candidates are requested to give maximum options verifying the seats available.

The Merit list of ACAP seats will be published by the system on line at 11.30 am. There after the college will admit the candidates as per Inter- Se-Merit.

For Round III onwards, there is **no Verification of documents** by CET CELL, it will be sole responsibility of the admitting College. Colleges should overlook the remarks given against the document uploaded and satisfy themselves for eligibility as per the prescribed norms. Any wrong document and wrong admission will be rejected by DHE and ARA and the college will be solely responsible for the same.

No candidate without CVC/EWS/NCL is to be admitted on the reserved seat.

EWS candidate can be considered as open category candidate if he is eligible as per open category eligibility criteria.

The Seat acceptance fee is to be paid by the candidate from the college log in. Colleges should verify the documents first then make candidate pay the Seat Acceptance Fee. Seat acceptance form is onetime fee and is non-refundable.

**All Candidates and all Colleges of Education to take advantage of this facility.**

All Instructions in the Notices mentioned in the reference remain unchanged and are to be followed scrupulously.

This Extension facility mentioned in Table Two above can be made applicable to Management Quota candidates and admissions also. The link of admitting candidate will be active till 11:59 PM on 5 March 2022.
