Shri Jesus Lall, Chairman of Vidya Vikas Education Trust, informed the trustees of the Trusts in the context of Govt. Maharashtra's GR. dated 31st December 2018 which is regarding fee fixation by minority institutions. All the trustees unanimously have agreed to fix fee for The Lord's Universal College of Education as per the Government Resolution.

उपरोक्त विषयावरील आपल्या संदर्भाधीन पत्रास अनुसरून कळविण्यात येते की, रिट याचिका क्रमांक ६१७६/२०१७ मध्ये मा. उच्च न्यायालयाने दिनांक ११.१.२०१८ रोजी दिलेल्या निकालाच्या अनुषंगाने विधी व न्याय विभागाने खालीलप्रमाणे अभिप्राय दिलेले आहेत:-

"Vide Notification dated 25.08.2010 issued by the National Council for Teacher Education, Regulation 4(B)(c)(iv) was inserted prescribing that each minority institution shall be entitled to have its own fee structure subject to the condition that there would be no profiteering and capitation fee. Also in Para No.5 of the Judgment, the Department had clarified in affidavit that it is prerogative of the Minority Institution to fix their own fee structure. Therefore, fee structure prescribed for the Unaided/Permanent un-aided B.Ed., M.Ed., B.P.Ed., Colleges by the Shikshan Shulk Samiti would not be applicable to the Minority Institution."
